

**ENTRY FEES:** Classes 1-14 & 17-18 are \$25 non-members, \$20 members with an Office Fee \$15. Classes 15-16 are \$15 non-members, \$10 members with no office fee. *Make checks payable to SDCTA.* \$30 will be charged for all returned checks.

**FOOTING:** Clay sand mix ring under covered arena. All tests to be ridden in a standard 20 x 60 meter arena. Separate grass warm-up area.

**NOTE:** Management reserves the right to add or divide classes. **NO DOGS PLEASE**. All riders must wear protective headgear when mounted. Braiding and jackets are not required- costumes allowed for all classes. English boots (tall or paddock style) are required. No cowboy boots or high heeled boots are allowed unless showing Western Dressage.
