NO REFUNDS after closing date except in case of cancellation of show due to acts of God, terrorism or other emergency (refunds of class & stall fees only), show to be rescheduled, dates to determined. ALL RETURNED CHECKS ARE SUBJECT TO A \$45 SERVICE FEE. If full payment is not received or a check for entry fees is returned, the entry will be placed on a waiting list until all fees are paid in cash, money order, or cashier's check. A \$20 incomplete entry fee will be charged for all entries received which do not include a copy of all USEF/USDF cards (paper entries only). #### **AWARDS:**

Ribbons to 6<sup>th</sup> place, Ribbons for CH and Res CH of USDF and FEI divisions (excluding FS, Intro & Opportunity) Ribbons for each division (AA, Jr/YR, Pro) of a class that has 3 or more entries High Point AA over 50 in regular class (must include birth date on entry to be considered). Ties will be broken in accordance with USEF rules.

You must be present to pick up your ribbons. No ribbons will be mailed.

**STABLING:** Permanent 12x12 stalls w/clay floor & doors. Initial shavings NOT included. For pre-ordered shavings delivered to stall add to your entry at \$10/bag. #### **Amateur Classes (AA)**

- o Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach age 22.
- o Only active United States Equestrian Federation members may obtain amateur status. (Exception: Equine Canada members in possession of current EC membership may sign for USEF Amateur status on a show by show basis at no cost).
- o Participants must possess current USEF Amateur status and qualify under the USEF Amateur rules. o If opportunity classes at Dressage Competitions are restricted to amateurs, riders are required to have an amateur status with USEF.

The Junior/Young Rider Classes (JR/YR) Riders are eligible to compete in these classes until the end of the calendar year in which they reach the age of 21

Classes per Day Horses are limited to a maximum of three Dressage rides per day at Fourth Level and below or two Dressage rides per day above Fourth Level. Horses competing at both Fourth Level and Prix St. Georges, or their equivalents, are limited to two Dressage rides per day. Dressage Seat Equitation, Quadrille, Pas de Deux and Materiale classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.

**Consecutive Levels** Horses may enter no more than two consecutive levels, Freestyle levels included, at any one competition.

Arena Size All classes will be conducted in a standard size arena (20 m x 60 m)

**Current Rules:** The rules may have changed from the current USEF Rule Book. It is the competitor's responsibility to check the current USEF Rule Book for any changes. Current rules can be found on www.usef.org.

#### **GENERAL RULES**

#### Entries must be RECEIVED by May 31, 2024

Payments at the show must be in the form of a check or cash.

Your entry is incomplete if you do not include copies of a CURRENT Coggins & Vaccination record (Flu/Rhino), USEF Entry Agreement (All mandatory signatures), USEF Waiver for each member listed on the entry, CURRENT USEF & USDF cards (Horse, Owner & Rider) and CURRENT USEF (Trainer, Coach). The fee is \$20 for incomplete paper entry! Enter ONLINE to avoid late fees; mailing fees; and submitting card copies: www.foxvillage.com.

Riders assume responsibility for checking confirmations to verify information and entry accuracy. Show website https://entry.foxvillage.com/ for entry, management not responsible for errors, omissions.

The show office will be open from 12:00pm until 6:00pm Friday, From 1 hour before the show until 1 hour after the end of show Saturday & Sunday.

## NO PARKING AROUND BARNS EXCEPT WHEN <u>ACTIVELY</u> LOADING OR UNLOADING FOR A MAXIMUM OF 30 MINUTES.

REMEMBER TO BE CONSIDERATE OF OTHERS WAITING TO LOAD OR UNLOAD.

#### **ENTRY DOCUMENTATION REQUIREMENTS**

- Current USEF membership and Safe Sport Proof (or Show Pass from USEF, 1/yr) for Rider, Owner, Trainer and Coach (if applicable).
- Current USDF membership (or n/m fees) for Rider and Owner. Rider's USDF membership may be either Participating or Group, Owner's USDF membership may be Participating, Group or Business; if Rider/Owner's USDF # is non-member ID #, the USDF n/m fee must be paid.
- USDF Horse ID minimum.
- For Adult Amateur classes USEF membership card must declare Amateur
- Juniors and Young Riders must include birthdate.
- Freestyle entries copy of a T- 4: 63% + test; FEI: 60% + test at the highest test of the MFS level or higher (exempt: FEI Jr/Yr/Pony/Para). Qualifying tests must come from a USEF/USDF licensed Dressage Competition, Federation Licensed or FEI recognized Dressage Competition, or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition.

#### FOR GAIG / USDF QUALIFYING CLASSES ALSO INCLUDE:

- Check "Qualifying" and add \$15 per Qualifying class.
- USEF and USDF Horse Registrations (no HID #s).
- Rider must have current Participating USDF membership; Owner must have current Participating or Business USDF membership.
- Rider and Owner and Trainer must have current USEF membership including up to date Safe Sport Training.

ALL ENTRIES must have THREE signatures - Rider, Owner and Trainer – by adult. Legal Guardian must sign for riders under 18 yrs. Trainer blank must be signed by person over 18 who assumes responsibility for horse. See <a href="https://www.usef.org">www.usef.org</a> and/or USEF Rule Book for further details on entry requirements. USEF waiver must also be signed.

#### **ON-LINE ENTRIES:**

Visit <a href="https://entry.foxvillage.com/">https://entry.foxvillage.com/</a> to enter on-line and pay major credit card - OR Print and Mail with your check. You will choose the show you wish to enter and will be required to enter the class number(s) you wish to ride and the stabling you need. Your fees will be totaled automatically. You will have the opportunity to print your completed entry for your records and will receive an automated email receipt. You will be required to sign electronically. Juniors must have ADULT signatures in all blocks. You may upload your negative coggins and vaccination records (and, if applicable, your MFS documentation). Please NOTE – online entries are NOT accepted without payment – the email receipt is your proof of payment.

#### **USEF RULES**

## All USEF & USDF rules shall be enforce from the time the first competitor has arrived on the show grounds until the last competitor has left the grounds.

It is the duty of the rider to know the rules applying to showing in the Dressage Discipline. It is the competitor's responsibility to check the current 2024 USEF Rule Book for any rule changes. Refer to www.usef.org for more information on current rules.

Effective April 1, 2016: Per GR844 At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhino pneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian.

In accordance with DR126.2b(3) Competitions may reserve the right to fill a competitor's subsequent ride times if that competitor fails to notify the competition secretary of his/her intention to scratch (i.e. a "no show").

Effective April 1, 2013: In accordance with DR120.1.1 Protective headgear in compliance with the accepted testing standards published on the Federation's website. Protective headgear must carry the applicable quality testing tag and/or label. See GR801. From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, mounted participants in exhibition classes, and those competing in all classes and tests, including Para Dressage tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. The harness must be secured and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding until the headgear is properly in place.

In accordance with DR121.19 Numbers. All competitors must complete check-in at the show office and receive a show number, before schooling or riding on the show grounds. Failure to check in at the show office prior to schooling will result in the issuance of a Warning Card. Competition-assigned numbers, or the same number in a personal numbering format, must be worn and visible at all times when a horse is being handwalked, exercised or ridden, under penalty of elimination.

In accordance DR126.2i.1: Tack Inspections. Inspection of saddlery and equipment (except bits) must be done at the direction of the technical delegate. Ring stewards appointed by competition management are required to inspect the saddlery, dress and equipment worn by at least one-third of the horses in a class immediately as the horse leaves the arena using a new disposable protective glove on each hand for each horse. In championship classes, saddlery, dress and equipment inspections are required for each horse. When an inspection is conducted, all equipment including fly hoods, nosebands, curb chains, whips, bits, and spurs on both sides must be inspected. The ring steward must also inspect the horse for evidence of blood.

1.a. Exhibitors must present bridles and bits, if and when requested, to the technical delegate for inspection utilizing the methods, timeframe(s) and location(s) identified by competition management with the agreement of the technical delegate. These methods must be communicated to the competitors prior to the start of the competition. The technical delegate must inspect at least 50% of the bits and bridles of horses entered in the competition. Technical Delegates must also conduct random ringside bit checks immediately after rides are completed, some of which can be included in the 50%, using a new disposable protective glove on each hand for each horse.

1.b. Inspection of saddlery and equipment is not required nor advised for group classes such as Dressage Seat Equitation and Materiale. When close inspection of saddlery, bits and equipment is required in order to determine compliance with DR 121 or other equipment provisions, a TD shall accompany the horse to its stall, trailer or other designated area to conduct such equipment inspections.

1.c. In Breed restricted classes at Regular competitions, a ring steward, at the direction of the technical delegate or C2 Steward (if eligible for the classes held), will do a hands-on inspection of saddlery and equipment including bits of at least one-third of the horses in a class immediately as the horse leaves the arena. New disposable protective gloves must be utilized with one on each hand for each horse.

1.d. When non-permitted bits, saddlery, or equipment are identified prior to the horse having worn the non-permitted items, there will be no elimination. Elimination will occur only when the horse is wearing non-permitted items or they are identified immediately after use. Legal whip length is 120cm or 47.2" at all times while on show grounds.

Sharps containers are located in each barn. In accordance with USEF GR1210.4 Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.

**In case of cancellation** of show due to acts of God, terrorism or other emergency, the show will be rescheduled, dates to be determined. No refunds of office fees.

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

#### **ATTENTION COMPETITORS**

Each competitor is responsible for supplying management with correct applicable numbers (USDF and USEF) for horse, owner, rider, and trainer, before the day(s) of the competition.

The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

#### **SDCTA/FACILITY RULES**

\*\*\*\*Arrival time at show grounds is no earlier than 11:00 am Friday\*\*\*\*

NO PARKING AROUND BARNS EXCEPT WHEN ACTIVELY LOADING OR UNLOADING FOR A MAXIMUM OF 30 MINUTES.

REMEMBER TO BE CONSIDERATE OF OTHERS WAITING TO LOAD OR UNLOAD.

\*\*\*All riders and trainers (except when mounted), coaches, grooms, friends and associates of a competitor must stand behind the railings of all riding and warm-up areas except when lunging. When lunging, only the person lunging the horse shall be in the lunging area\*\*\*

\*\*\*A \$20 incomplete entry fee will be charged for all paper entries received which do not include copies of all required USEF/USDF cards.\*\*\*

The expiration date of a Coggins test is one year from the "blood drawn on date". The name of the horse on the coggins must match the name on the entry form. Vaccination records (Flu/Rhino) are only valid for 6 months.

All horse trailers MUST be parked in designated trailer parking areas. All motor vehicles must be parked in designated parking areas and away from the barns. RV parking is available.

\*\*\$50.00 stall change fee for anyone changing stalls without <u>prior</u> permission of management. If you use an empty stall FOR ANY REASON OR FOR ANY LENGTH OF TIME you will be assessed an \$95 stall fee, NO EXCEPTIONS.

Management reserves the right to split, combine, delete, or add classes dependent on entries.

Management also reserves the right to add or substitute judges or make any changes required by circumstances. Management may also limit the number of entries if required by circumstances.

Lungeing is allowed in designated areas only.

**All owners and competitors are personally responsible for** damages to third parties caused by themselves, their employees, their agents, or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events.

**NO AWARDS OR RIBBONS WILL BE MAILED.** You must be present to pick up your awards/ribbons. **Prize money**, if applicable will be mailed within 30 days upon completion of the competition.

For the safety of exhibitors, horses and spectators, dogs must be leashed at all times ©

#### **TENTATIVE SCHEDULE**

(Subject to entries received and USEF scheduling requirements)

FEI & 4th Level will generally be morning classes; 3rd and 2nd Levels will generally be mid-day; Freestyles will be after the lunch break; 1st, Training, Intro & Opportunity will generally be in the afternoon, unless ride conflicts necessitate a scheduling adjustment.

- Make sure to bring a backup in the format requested.
- Be present for your sound check.
- Know the rules for the level you are riding. This includes forbidden and allowed movements for your level.

## GREATAMERICAN, INSURANCE GROUP USDF REGIONAL Dressage CHAMPIONSHIPS

#### 2024 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at <a href="www.usdf.org">www.usdf.org</a>. Please refer to the 2024 USDF Member Guide for the comprehensive list of rules and requirements for this program.

#### Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

#### Rider:

- Must have a USDF Participating\* Membership (PM).
- Must have a USEF membership (Active or Life).

#### Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).
   A horse is not required to have breed registry papers.

#### Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or
  Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF
  membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF.
   For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both
  USEF and USDF.
- \* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division.

#### Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8<sup>th</sup> Place and gift certificates awarded to top four riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

#### **Qualifying Requirements**

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

 Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDFrecognized Dressage competition within the qualifying period of the applicable regional championship.

<u>or</u>

b) Qualified to compete in any regional dressage championship class (excluding freestyles).

#### **Membership Requirements**

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

#### USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

#### Exceptions

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
  sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
  Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
  exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
  academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
  identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

#### Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program. **Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:
